Personal Observations

- First night excursion to ballgame. No other activity for persons not wanting to attend. Hospitality rooms were not open until 7:00 p.m.
 - Activities such as corn hole, horse shoes, bar-b-que might be considered
 - Need to find a hotel that can accommodate
 - Find hotel with better atmosphere
- Conference tends to be for mature firefighters/retired, etc.
- In order to pull in younger crowd, consider 2-day family packages that are more affordable.
- Recommend having 1, 2, 3 day registration fees
- · Recommend having more for young firefighters
- · Handout was attractive, nice addition

Meeting with KFA Staff

- Recommended setting up an organizational chart
- · Set up fun fund raising events poker run, 5k run/walk, reverse raffle
- · Get departments to make contributions of \$100 \$500 a year
- Having a regional conference as opposed to a local conference creates problems due to having such a large committee or you find that you are running over each other.
- Attendees are given tags to wear, tags do not show events registered for, recommend having activity codes on the tag – VFIS provides tags
- Didn't anticipate number of late registrations (30) which was somewhat overwhelming and unexpected because of the additional charge, badges had to be printed on the spot
- 403 attended the banquet
- 310 total registrants (45 extra banquet tickets were purchased)
- Recommend outsourcing most activities
- · Renting buses
- Need to provide childcare 15 teenagers, 8 that needed child care, big expense, but takes liability off association

Proposed actions to support development of a Board of Directors for the Dixie Firefighters Association:

 Board shall be comprised of 1 voting member from each county: Breckenridge, Hardin, Grayson, Larue, Marion, Meade, Nelson, and Washington.

2. One Board member shall be elected as Chair and shall conduct the meeting and

shall only vote in the event of a tie.

3. County appointees to the Board shall be nominated and selected by a county fire chiefs association, firefighters association, or by a majority vote of those departments that are listed as Dixie Firefighters Association members in that county. In the event of intra-county conflicts, or a position defined as "vacant", a county judge may appoint a director to fill the unexpired term.

4. The Executive Committee of the Dixie Firefighters Association shall attend Board of Directors meetings in a non-voting capacity. The President and Past President shall attend as non-voting Board members. The Secretary shall record the minutes of the Board of Directors. The Treasurer shall advise the Board on all

financial transactions of the Association.

The Area 5 State Fire Rescue Training Coordinator shall be a non-voting member of the Board of Directors.

Meetings of the Board of Directors shall be open to the public but may be closed for personnel matters.

7. A Board member shall not concurrently hold an Executive Committee position.

Requirements of Board members:

1. Attend two (2) meetings per year plus special called meetings.

 Serve as a liaison between the Dixie Firefighters Association and any emergency services organization, agency or business within their county to promote the advantages of membership, meeting attendance and involvement in Association projects and activities.

Participate in the development and implementation of a Strategic Plan for the

Dixie Firefighters Association.

4. Serve a two (2) year term of office. Members may succeed themselves on

resubmittal by their county.

Provide oversight for the Executive Committee as they conduct the daily business of the Association in conjunction with the Strategic Plan.

Subject: Emergency Preparedness

On behalf of the Lincoln Trail Regional Citizen Corps Council I would like to offer your childcare center the opportunity to receive a free weather radio in coordination with a visit from your local fire department.

The emergency planning function of a fire department consists of more than smoke detector programs. The fire department provides varied services to the local community beyond that of emergency response. Other services include fire prevention, emergency planning, and in some cases, fire code and safety inspections.

Code compliance with smoke detectors, fire alarms and drills is only part of the picture. A good weather radio and reliable battery operated radio may provide the only means of hazard communication during times of disaster. The weather radio can alert you to severe weather and is also used for some other emergency broadcasts.

Whether paid or volunteer, each firefighter will typically do what they can to assist you in planning for an emergency at your facility. Disasters may bring multiple calls for service; and while childcare facilities are some of our most important community locations, it is not always possible for responders to get to you immediately. The Regional Council and local Fire Departments would like to help you extend your planning beyond fire/tornado drills and then leave you with a weather radio for your facility.

To receive a radio, contact your local fire department and schedule a time for them to visit your facility, conduct a preparedness training with your staff, assess your current emergency plan or help you develop one. Once the visit is complete, a weather radio will be left with you.
